- **Transfer of Powers**
 - o The Executive Board asks the Senate to release their individual voting authority to the Student Government Executive Board for the summer months starting 4/14/2020 and ending 9/8/2020 to allow for continued business and operations of the organization while the Senate is in recess. This authority is limited to decisions regarding the day-to-day operations of the organization and minor financial decisions. This release of voting authority does not give the Student Government Executive Board the authority to make major decisions such as policy changes or large financial purchases or disbursements without the consent of the Senate. Any decision or action made through the Release of Voting Authority still requires notice to the Senate. Senate members are strongly encouraged to check their SNHU student email regularly as they may be required to submit an electronic vote regarding any major financial decisions. No policy changes may be made during a Senate Recess.
